A NETWORK WITH LEADING UNIVERSITIES WORLDWIDE

Thanks to a well-established system of relations and exchanges with 275 prestigious schools in 54 countries around the world, Bocconi students and Faculty benefit from international experiences, research, and joint teaching projects.

There are a wide range of international programs available to graduate students, subject to admission through a selection process:

- **Double Degree Programs:** offered in 20 countries with 28 prestigious universities, they represent an opportunity to complete a second degree, in addition to the Bocconi degree. Students spend one year at Bocconi, acquiring core knowledge and

skills, and specialize in their field of interest while attending one year at one of the host institutions.

- **Exchange Programs:** each year, they enable 550 graduate students to experience one semester of studying abroad, according to bilateral agreements with highly selected universities all over the world.

In addition, further opportunities for international study are offered:

- **CEMS MIM:** a global program, of which Bocconi is a founding member and the only Italian partner university, offered during the second year of the **MSc in International Management**. Admission will take place at the same time as admission to the MSc program.
- **CHINA MIM (Bocconi-Fudan):** for this program only, the first year is held in Shanghai and the second year is at Bocconi in the **MSc in International Management**. Students must graduate by June 2019. Admission will take place at the same time as admission to the MSc program.
- **Bocconi-ESSEC Double Degree:** a program offered to students interested in the **MSc in Management** and in gaining a deep insight of both European and Asian markets, spending one semester in Milan, one at ESSEC Singapore, one at SDA Bocconi Asia Center (Mumbai) and one at ESSEC Cergy. Admission will take place at the same time as admission to the MSc program.
- **Bocconi-Sciences Po Double Degree:** students in the program spend their second year at the prestigious Institut d'Ecole Politique Sciences Po in Paris, during the **MSc in Politics and Policy Analysis**. Applicants to this program are required to complete a specific application.
- **Bocconi-LSE Double Degree:** this program allows **MSc in Politics and Policy Analysis** students to study with leading experts in public policy and politics at the European Institute at LSE in London. Applicants to this program are required to complete a specific application.

ELEMENTS OF EVALUATION

Online application and dossier with:

- **Results of the GMAT or GRE test**
 - compulsory
- **Grade point average of exams or courses passed during the undergraduate program**
- **Evaluation of the applicant's Curriculum vitae / Resume and Personal Statement**
A video presentation is an additional element of evaluation (not compulsory).

Online application is available starting from mid-October 2018. The selection process is on a rolling basis and the results should be delivered within approximately one month after the respective deadlines.

Approx. 13,800 euros per year (academic year 2018-2019)

FINANCIAL AID AND SCHOLARSHIPS

Merit-Based Awards

Offered to outstanding students by the University, in cooperation with partner companies and institutions. They include a full tuition waiver, and a limited number of students may also be offered accommodation. Merit Awards will be automatically renewed for the second year provided merit requirements are met. **A formal application is not required.**

Bocconi International Awards

Offered to outstanding international applicants, these include a 50% reduction in University fees. They will be automatically renewed for the second year provided merit requirements are met. **A formal application is not required.**

Need-Based Awards

Bocconi University, through ISU Bocconi - the Student Assistance and Financial Aid Center, coordinates and provides students with grants and services providing equal access to university studies as foreseen by the Lombardy Region. **A formal application is required.**

For US Citizens

Bocconi has been approved for Federal Financial Aid for American students (FAFSA). This means that students can apply for a federal loan while studying at Bocconi. The Federal School Code for Università Commerciale Luigi Bocconi is **G30787**, listed under Foreign Country.

HOUSING

Bocconi University offers students a total of about **2000** housing rooms in **8** University Residences:

- Approximately 20% of the rooms are assigned at a reduced rate; access to this kind of housing is based on the economic situation of the student's family
- The remaining rooms are reserved for full rate housing; no evaluation of the economic condition of the family is necessary for assignment.
