

Bachelor's Degrees

QUALIFICATIONS

In order to enrol in any undergraduate degree programme, students must hold a University Entrance Qualification (UEQ).

For students who have completed their high school studies abroad, the UEQ must be a valid qualification which allows admission to University in the country where it was obtained..

ADMISSION

1) Preliminary Evaluation: If you are an EU or non-EU student with an international qualification and you wish to enrol in a Bachelor's Degree Programme at Ca' Foscari, you must request a preliminary online evaluation of your qualifications. After uploading the required documentation and completing the procedure you will be informed of the outcome by email.

2) Limited and Open Admission:

There are two types of admission to undergraduate programmes: *limited* and *open* admission ("accesso programmato" and "accesso libero").

- Students applying for *limited admission programmes* are ranked following a selection process prior to enrolment and must therefore receive confirmation of acceptance before enrolling.
 - **EU students** will be required to take the entrance exam on both general and specific knowledge relevant to their chosen curriculum.
 - **Non-EU students** will be required to take an exam via Skype to certify the required competences.
- Students applying for open admission programmes enrol directly.

LANGUAGE REQUISITES

All undergraduate programmes require a minimum **B1 level of English**, while some programmes require a B2 level (see the individual degree listings). Students lacking such certificate are required to fulfil an Additional Learning Requirement (OFA) in English following enrolment and have one year to complete the requirement. ⁽¹⁾

• For Italian-taught graduate programmes only: A B2 level in Italian language is *highly recommended* for any non-Italian native speaker.

Non-EU students residing outside of Italy must submit one of the certificates recognised by the Ministry of Education, Universities and Research (MIUR) attesting a B2 level in Italian, or take the Italian language test held at the University prior to the beginning of the academic year.

Business Administration and Management

ENTRY REQUIREMENTS AND ADMISSION

Non-EU Students will be required to take an exam via Skype to certify the required competences.

ENTRY REQUIREMENTS AND ADMISSION

For all students, a certified knowledge of English language at least at a B2 level is required. **EU** Students will be required to take an entrance exam on logic and on general culture. **Non-EU** Students will be required to take an exam via Skype to certify the required competences.

⁽¹⁾ Students not in possession of the required level of English certification, or who fail to pass the English language test, will be required to meet Additional Language Requirements in English (OFA): this requirement must be met by September the 30th of the year after enrolment; after this date, it will no longer be allowed to take any further exams until requirements are met. Master's Degrees

QUALIFICATIONS

In order to enrol in any graduate degree programme, you are required to have obtained a University academic qualification (of at least three years), or a post-secondary school qualification (of at least three years) awarded by a non-university higher education institution, as long as it is considered sufficient to allow entry to higher level university studies in the country where it was obtained.

ADMISSION

- 1) Preliminary Evaluation: if you are an **EU** or **non-EU** student with an international qualification and you wish to enrol in a Master's Degree Programme at Ca' Foscari, you must request a **preliminary online evaluation** of your qualifications. After uploading the required documentation and completing the procedure you will be informed of the outcome by email. - 2) Limited and Open Admission:

There are two types of admission to graduate programmes: *limited* and *open* admission ("accesso programmato" and "accesso libero").

 - **EU students** will be required to take the entrance exam on both general and specific knowledge relevant to their chosen curriculum.
 - Non-EU students will be required to take an exam via Skype to certify the required competences.
- Students applying for open admission programmes, after the Preliminary Evaluation, enrol directly.

ADDITIONAL ENTRANCE REQUIREMENTS

Students must be properly prepared to embark upon their chosen graduate degree programme, and must possess the knowledge necessary to follow their chosen pathway successfully. **All students** (Italian, EU citizens, non-EU citizens) with non-Italian qualifications must request, in addition to the Preliminary Evaluation, an online Evaluation of their academic credentials and requisites before enrolling.

Once the documentation is submitted, the Degree Programme will check that you have the relevant requisites and you will be advised of any entry requirements you must fulfil in order to be able to complete your enrolment.

LANGUAGE REQUISITES

All graduate programmes require a minimum of **B2 level of English** and students must provide certification prior to enrolment unless otherwise specified under the individual degree listing. Students lacking such certificate are required to fulfil an Additional Learning Requirement (OFA) in English following enrolment and have one year to complete the requirement. ⁽¹⁾

• For Italian-taught graduate programmes only: A B2 level in Italian language is *highly recommended* for any non-Italian native speaker.
